All ropers must rope in sequence. NO PROFANITY PERMITTED! Unnecessary roughing of cattle, i.e., high hock, roping eyes, unnecessary roughness, etc. shall be grounds for disqualification of the team. In the event of disqualification of the team all fees shall be forfeited and applied towards cattle damage. The judges shall determine all disqualifications, with all decisions made by judges being final.

**No alcohol in open areas. Please pick up ALL MANURE inside and outside of arena.
NO refunds of registration fees without vet or medical certificate**

EVERY PARTICIPANT IN A LAKEDELL RANCH ROPING SANCTIONED EVENT (CALLED THE ROPING), SHALL CAREFULLY READ THIS NOTICE BEFORE SIGNING. No Participant Will Be Allowed To Attend Prior to Reading and Signing This Release and Acknowledgment Form.

TO: The Lakedell Agricultural Society their respective directors, officers, employees, representatives, agents, instructors officials, volunteers, business operators, and site property owners, (all of them collectively called the "HOST").

I am aware and understand that there are Inherent Dangers, Hazards, and Risks, (collectively called "RISKS") associated with Equine Activities and Roping Events. I Acknowledge that these Inherent "RISKS" of Equine Activities and Roping Events mean those Dangerous Conditions which are an integral part of Equine Activities and Roping Events.

I understand that injuries resulting from such "RISKS" are a common and ordinary occurrence associated with Equine Activities and Roping Events. I freely accept the fully assume all the "RISKS" and possibility of personal injury, death, property damage or loss from being a participant. I acknowledge that it remains my sole responsibility to act in such a manner as to be responsible for my own safety and to participate with in my own limits. In consideration of the "HOST" permitting my Participation in the "ROPING" , I together with my heirs, executors, administrators and assigns, (collectively called "Legal Representatives") agree as follows:

- 1) To Waive All Claims that I may have against the "HOST";
- 2) To Release the "HOST" from Any and All Liability for and loss, damages, injury, or expense that I or my "Legal Representatives" may suffer as a result of my participation in the "ROPING" due to any cause whatsoever INCLUDING NEGLIGENCE ON THE PART OF THE "HOST"; and
- 3) TO HOLD HARMLESS AND INDEMNIFY the "HOST" from any and all liability for any property damage or personal injury to any third party resulting from my participation in the "ROPING".

I have read and understand the Rules of the "ROPING" which apply to me. I agree to abide by those RULES and Acknowledge that a breach of the Rules may among other things result in my expulsion from the "ROPING". Before I sign this Release and Acknowledgment, I read it and I state that I understand it. I am aware that by signing this Release and Acknowledgment, I am waiving certain legal rights which I might have against the "HOST", or, if I die, by signing this Release and Acknowledgment, I am waiving certain rights that my "Legal Representatives" may have against the "HOST".
